



STANDUP PADDLEBOARD LESSONS & RENTAL WAIVER, RELEASE AND AGREEMENT

(Please read completely before signing and ask questions if there is anything you do not understand.)

In consideration of being allowed to participate in any way in South Surf stand up paddle boarding ("South Surf") lessons, rentals, related events and activities, the undersigned acknowledges, appreciates and agrees that:

1. Stand up paddleboards, leashes, paddles, all equipment used in the sport and the natural surroundings, including water, docks, rocks, and shoreline areas are potentially hazardous objects; and lake and cedar creek conditions can change quickly, the water may decrease in temperature rapidly, wave height may increase or decrease, visibility in the water may fluctuate, current may be strong, or depth of water will change, under and above water obstacles such as rocks may be present and I respect the lake and creek's power.
2. An SAE approved Personal Flootation Device and SUP leash were provided and I acknowledge that South Surf has encouraged me to wear them at all times while stand up paddling; and I will not approach any obstacle or object, including but not limited to boat wakes, shorelines, shallow water, rocks, or docks, in an unsafe manor such as remaining in a standing position.
3. Stand up paddling and swimming can be strenuous physical activities involving varying depths of water; and I am in average to above average physical condition; and my swimming ability is adequate to engage safely in the sport; and
4. The risk of injury from the activities involved in this program is significant, including the potential for permanent paralysis and death, and while particular rules, equipment and personal discipline may reduce this risk, the risk of serious injury does exist.
5. I have no preexisting medical or other condition that would affect the safe participation in these activities; or I have consulted my physician as to the advisability of participating in these activities; and I will inform South Surf of any changes in my health or physical condition prior to any lesson or rental; and
6. I knowingly and freely assume all such risks, both known and unknown, even if arising from the negligence of the releases or others, and assume full responsibility for my participation; and
7. I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring such to the attention of the nearest South Surf staff immediately; and
8. Not to allow any alcoholic beverage or recreational drugs to be used while on or prior to the use of renting or participating in any stand up paddle board use; and
9. Allow South Surf to reclaim damage expenses or loss occurring to watercraft and other rental gear while I am renting or using it by means of the blank credit card voucher I have signed, or by any other means necessary; and
9. I, for myself and on behalf of my heirs, assigns, personal representatives and next of kin, hereby release and hold harmless Sheila Rodger and South Surf, their officers, officials, volunteers, agents and/or employees, other participants, sponsoring agencies, sponsors, advertisers, and, if applicable, owners and lessors of premises used to conduct the activities ("Releases"), with respect to any and all injury, disability, death, or loss or damage to person or property, whether caused by the negligence of the releases or otherwise.

I HAVE READ THIS RELEASE OF LIABILITY AND ASSUMPTION OF RISK AGREEMENT, FULLY UNDERSTAND ITS TERMS, UNDERSTAND THAT I HAVE GIVEN UP SUBSTANTIAL RIGHTS BY SIGNING IT, AND SIGN IT FREELY AND VOLUNTARILY WITHOUT ANY INDUCEMENT.
